RECEIVER'S RESPONSE TO MOTION FOR RELIEF FROM FILING FUTURE STATUS REPORTS AND UPDATES

Peggy Hunt, as the Court-appointed Receiver in the above-captioned case (the "Receiver"), by and through counsel, hereby files this *Response* to the *Status Report and Motion* for Relief from Filing Future Status Reports and Updates [Docket No. 150] (the "Motion"), filed by Defendant Charles D. Scoville ("Scoville"). For the reasons stated herein, the Receiver requests that the Court deny the Motion and require Scoville to continue filing status reports with the Court. In support hereof, the Receiver replies and states as follows:

### I. RELEVANT FACTS

- 1. On May 14, 2018, Scoville met with the Receiver, Receiver's counsel, and counsel for the SEC.
- 2. At the meeting, Scoville denied any involvement in the transfer of the "Property" located in Manchester, England, as alleged in the Receiver's *Ex Parte Motion Seeking an Order to Show Cause Why Charles D. Scoville Should Not Be Held in Contempt* [Docket No. 128). Scoville also stated that he wanted to cooperate with the Receiver in determining who transferred the Property.
- 3. On May 16, 2018, the Receiver's counsel sent an email to Scoville's counsel asking Scoville to sign a letter authorizing the British company which allegedly acted on Scoville's behalf in the transfer of the Property to divulge information about the transfer to the Receiver. Receiver's counsel also attached a draft of the letter (the "Authorization Letter") for Scoville's approval and execution. A true and correct copy of this email and the attached letter is attached hereto as **Exhibit A**.
  - 4. Scoville's counsel did not respond to this email.
- 5. On June 5, 2018, the Receiver's counsel sent a follow up email to Scoville's counsel requesting an update on the Authorization Letter. A true and correct copy of this email is attached hereto as **Exhibit B**.
- 6. Scoville's counsel did not respond until June 15, 2018, when he notified the Receiver's counsel that getting Scoville's signature on the Authorization Letter would be delayed because Scoville had been arrested and was in the Salt Lake County Jail.

7. On June 17, 2018<sup>1</sup>, Scoville signed the Authorization Letter, and Scoville's counsel sent the executed Authorization Letter to the Receiver's counsel on June 18, 2018. A true and correct copy of the executed Authorization Letter is attached hereto as **Exhibit C**.

### II. ARGUMENT

The Receiver believes it is important that the Court and the parties in this action continue to receive reports on the status of Scoville's whereabouts. Although Scoville agreed to assist the Receiver in investigating the transfer of the Property, he has been slow to respond to the Receiver's requests. Scoville states in the Motion that since the May 14, 2018 meeting, "no request for assistance has been made" by the Receiver to Scoville. This is incorrect. The Receiver first requested that Scoville sign the Authorization Letter on May 16, 2018, more than two weeks before Scoville filed the Motion claiming no requests for assistance had been made. Additionally, it took more than a month for Scoville to sign the Authorization Letter after the Receiver first requested that he do so.

The fact that Scoville now faces criminal charges in the State Court makes it even more important that he continue to file status reports with this Court to allow the Receiver and the Court to follow his whereabouts and status. Therefore, the Receiver requests that the Court deny the Motion, and continue to require Scoville to file status reports and to ensure his cooperation with the Receiver.
